2. Operational updates

News:

Service Ontario will continue to use the Durham branch as a temporary location in March. A daily room rental rate will apply.

The 2024 unaudited year-end should be available in April, in time for the May meeting.

The Bruce County Bookmobile visited Elmwood every other week and had 69 visits. It will continue every other week in 2025. We hope to coordinate something in 2025.

The Friends of the Library will begin the process of dissolving the charity. The library will take over the book sale in June and October with many volunteers from the Friends Group.



Chief Librarian/CEO Report March 12, 2025

Starting in March, South East Grey Services will assist with income tax returns. In 2024, a total of 71 returns were completed, resulting in \$211,784 in benefits received by individuals.

Buildings:

The boiler needs to be replaced in the Durham Branch.

Many soffits came down at the Neustadt Branch due to the snow; they will need to be replaced in the spring.

Child & Youth - Kayla

Raising Awareness: February was a month of weather cancellations, but we still managed to hold most programs, including storytimes (with increasing participation!), a visit to the Kindergarten classes in Spruce Ridge, Read to a Dog, and others.

Innovative programs: Our homeschool group had the opportunity to test our new LEGO Education kits that combine the creativity of LEGO with the technology of coding! Kids were able to build Ferris wheels and other robotic creations using the LEGO Education kit and an iPad. We're excited to offer these LEGO kits as coding opportunities in other in-house programs as well.

Adult - Kimm

Adult programs continue to take a hit with the uncertain weather. March will see a movement towards programs to do with the outdoors and growing things, including a presentation by the Municipality's environmental officer on waste management, a local farmer's presentation on community-supported agriculture and a volunteer representative speaking on the Municipality's community garden and orchard. Approximately 122 adults took part in programs and events this past month.
